#### **Context:**

Under the direct supervision of the Head of Office / Project Manager, and in cooperation with the Senior Area Project Assistant, and in the framework of Semi-independent living as alternative care model for unaccompanied migrant children over 16, the Area Project Assistant will have the following duties and responsibilities :

#### **Core Functions / Responsibilities:**

1. Assist the Senior Area Project Assistant in the identification of new Semi-independent living units for unaccompanied and separated children.

2. Monitor the living conditions of unaccompanied children, in particular the good use of the equipment of the facility, the quantity and quality of the meal and the timely preparation or receipt of meals and their timely distribution (where provided), cleanliness of premises and compliance with safety requirements.
3. Coordinate the children's daily activities by mainly focusing in the organization of educational and recreational activities.
4. Monitor the weekly program of services at group or individual level or daily in the case of extraordinary activities.
5. Refer beneficiaries to Senior Area Project Assistant for commendable behavior or specialized support pathway as per the educators, caregivers and social workers reports.
6. Manage the storage and distribution of humanitarian assistance in the structure, including, for example, clothing and personal hygiene.
7. Liaise with government and local community authorities, sources and Services for the benefit of the children and the Project.
8. Cooperate, exchange information with and inform the competent Social Services Officers at the Social Welfare District Offices of all issues related to the Project.
9. Maintain a protocol and a file of incoming – outgoing documents and handles the correspondence.
10. Assist with the administrative issues arising in the context of cooperation with other agencies and bodies.
11. Undertake other duties as assigned.

### ***Required Qualifications and Experience***

#### **Education**

- School diploma from an accredited academic institution with four years of relevant working experience, or
- University degree in the field of psychology, sociology, social work with two years of relevant professional experience.
- Master's degree will be considered an advantage.

#### **Experience and Skills**

- At least two years of previous working experience.
- Previous working experience with children or semi-independent living units and/or knowledge on child protection will be a distinct advantage.
- Experience in team coordination is an advantage.
- Familiarity in working in a multi-cultural environment is desirable.
- Strong organizational, facilitation, communication, writing and presentations skills.

- Demonstrated ability to work well under pressure and keep deadlines.
- Strong work ethics and commitment to humanitarian principles.
- Good level of computer literacy.

## **Languages**

Fluency in **English** and **Greek** (written and oral) is required.

Any other IOM Official language is an advantage.
